MGA Amateur Public Links Championship Conditions & Regulations

ELIGIBILITY

Entries are open to amateur golfers who play at an MGA member club, maintain an up-to-date MGA/USGA GHIN Handicap Index not exceeding 12.0 (as determined by the June 10, 2009 Handicap Revision), and are public course players (i.e., a course which will accept a daily fee, at any time, notwithstanding any certain daily time restraints, is a public course). Amateur golfers holding membership at a semi-private club are eligible. Amateur golfers holding a membership in a private club and a public course are NOT eligible.

EXEMPTIONS

Upon receipt of the Entry Form and fee, the players in the following categories are exempt from Sectional Qualifying:

1. MGA Public Links Champions of the last five (5) years, if eligible.
2. Ten (10) lowest scorers and ties in the 2008 Massachusetts Public Links Championship, if eligible.
3. MGA State Amateur Champions the last five (5) years, if eligible.
4. 2008 MGA Junior, Senior and Mid-Amateur Champions, if eligible.
5. Top fifteen (15) finishers and ties in the 2008 MGA Player of the Year standings, if eligible.
6. 2008 MGA Player of the Year, Junior Player of the Year and Senior Player of the Year, if eligible.
7. Players who qualify for the 2009 U.S. Public Links Championship.
8. 2009 MGA State Amateur Quarterfinalists, if eligible.
9. 2008 NEGA Amateur and Senior Amateur Champions, if eligible.
10. Special exemptions as selected by the MGA.

ENTRY PROCEDURES

Entrants shall apply on the MGA Entry Form attached. Entry fee of \$75.00 shall be paid by every player.

Refund Policy: Entry fee will be refunded, regardless of reason, if the MGA is notified in writing before the close of entries. After the close of entries, regardless of schedule changes, entry fee will be refunded only in the event of injury or illness, and if requested in writing by July 6, 2009, subject to MGA Championship Committee approval.

Refunds will be issued, less a \$20.00 service charge, after completion of the Championship.

Late or incomplete entries will not be accepted. Entries by telephone, e-mail or fax will not be accepted. Deadline for entry means time of receipt at MGA office - not time of postmark. Entry should be mailed early to allow ample time for delay.

Entrants in the Sectional Qualifying and Championship Proper will be notified by mail or e-mail of their starting time, course assignment, and availability of practice privileges. If a qualifying location has more players than can be accommodated, some players will be transferred to another location. Transfers are final. Courtesy practice privileges are at the discretion of the host club.

A tie for a final place or an alternate's place in Sectional Qualifying shall be decided by a hole-by-hole play-off whenever possible. Alternates for the Championship Proper will be notified of their playing status by the MGA office.

NOTICE OF WITHDRAWAL

A player who decides not to participate must notify the MGA office (1-800-356-2201) by phone promptly. Failure to comply may result in a player's entry being rejected from future MGA competition.

SCHEDULE

Competition will be in two (2) stages at Stroke Play:

1. Sectional Qualifying - 18 Holes

RULES OF GOLF

Play will be governed by the Rules of Golf as approved by the USGA. Questions shall be settled by the Committee in charge of the competition consisting of those officials assigned by the MGA, whose decision shall be final.

CADDIES & AUTOMOTIVE TRANSPORTATION

Players may use caddies, pull carts and/or automotive transportation during Sectional Qualifying or Championship Proper.

DRESS CODE

Proper dress code for all stages of the competition will be strictly observed.

CELLULAR TELEPHONES

The use of cellular telephones is prohibited.

DISTANCE-MEASURING DEVICES

In this competition, a player may use devices that measure or gauge distance only (see the Note to Rule 14-3). However, the use of a distance-measuring device that is designed to gauge or measure other conditions that might affect a player's play (e.g., gradient, wind speed, temperature, etc.) is not permitted regardless of whether such an additional function is used.

GOLF SHOE POLICY

Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited. Penalty for breach of this condition: **Disqualification.**

PRIZES

The Ray C. Bump, Jr. Trophy will be presented to the Champion. Gold and Silver medals will also be awarded.

CONDITIONS/SCHEDULES

The MGA Executive Committee reserves the right to alter any of the conditions and schedules herein. The decision of the Executive Committee in any matter shall be final.
